Santioned Event Changes

Expression of Interest to Conduct an A20 show.

Regulations Part 5 – Conformation Show, Section 9, Clause 9A.3.1 reads as follows:

9A.3.1 Applications to hold a AAOS A20 show sanctioned by ANKC Ltd, and subsequently by the AAOS, must be sent in the first instance to the Member Body of ANKC Ltd where the show is planned to be held no later than 18 months prior to the intended show date and, if the application is supported by that Member Body, is then to be forwarded to ANKC Ltd for consideration. If approved by ANKC Ltd the application is then to be forwarded to the Secretariat of AAOS no later than 12 months prior, and no earlier than four

including the date of the event and closing of entries, classes, prizes, and the name/s of the contracted judge/s shall be submitted to the Administrative Officer for approval **at least four (4) months prior to the date of event.**

The close-off date is important. You can be charged a \$50 fee for late schedules.

Increase To Overseas Judges

Application Approval Fees - Effective 1 July 2025

In accordance with Item 7.3 of the October 2024 Annual General Meeting, the fees for

accompanied by the application fee. This fee will be refunded if the application is not approved. The timelines in this Section shall not come into force until 1st January 2024.

From 1 January 2025, expressions of interest will be called for and these applications will be approved at the October 2025 Board meeting. Once approved by the Board they will then be forwarded to the A2O Secretariat for their approval. This will mean that A2O Shows to be held between January and December of the following year will be required to be submitted prior to the October Board meeting the previous year, i.e., 2026 shows are to be submitted when expressions of interest are called for in early 2025.

\$121.00 - Applications lodged 9 months prior to the show

\$231.00 – Applications lodged less than 9 months prior to the show

The above fees include Dogs Australia obtaining verification of the qualifications of the judge and are GST inclusive and will apply for all applications received by the Dogs Australia office from 1 July 2025.

A new fee of \$33.00 (inclusive of GST) will be introduced from 1 July 2025 for each request to amend an existing approval.
