## Amended Dogs West Regulations

### A38.2 Confidentiality Obligations – Governance Panels

All members of a Governance Panel are required to maintain confidentiality pursuant to the terms of the Confidentiality Agreement executed by each member of the Governance Panel on their appointment to that Governance Panel. Should a member of a Governance Panel refuse to sign the Confidentiality Agreement, then they shall be deemed to have refused their appointment to that Governance Panel and they shall be removed with immediate effect from that appointment. If any member of a Governance Panel breaches the terms of the Confidentiality Agreement then it shall be within the Governing Council's complete discretion to determine the appropriate course of action in response to that breach, including but not limited to revoking or terminating the appointment of the member to the Governance Panel. **(08/24)**

### A71.7 Disciplinary Action - Procedures

71.7 No Governing Councillor or Deputy Governing Councillor appointed to the Tribunal and/or Judges Board who participates in a hearing which is the subject of an appeal to the Appeals Board shall participate in any debate or have any vote on the appeal.

### HT3 Results and Gradings

3.1 At the end of each track, the judge must complete his judging sheet marking PASS or FAIL and award the grading. At the end of the trial, results must be checked with the Chief Steward to ensure that certificates are made out correctly.

Regulations Part 5 – Conformation Show has been amended in accordance with 5.4 the June 2024 Special Board meeting minutes with the inclusion of new Clause 10.12. This amendment is effective from 1 January 2025.

10.12 Sire and Dam of Merit (Added 06/24, 5.4 - effective 01/01/2025)  
10.12.1 Sire of Merit (SOM) - A dog that has produced at least ten (10) Conformation Champion offspring.  
10.12.2 Dam of Merit (DOM) - A bitch that has produced at least five (5) Conformation Champion offspring.  
10.12.3 At least 1 of the conformation Champion titles (CH, GRCH, SUPCH, CIB, A2O) must have been awarded after the implementation date (01 January 2025)

However, Canine News Australia Post's delivery times have lengthened, requiring all content to be at the printers at least 5 days earlier than previous years. The suggestion is to amend Rule 17.5 from the first Friday of June to the second Friday of May. This will enable more time for the office to ensure the nominations meet the requirements and to place them in the Canine News.*

*By deleting reference to working days, it makes it clearer and less open to ambiguity with whose working days it refers to in these days of flexible working days. The day of the AGM may change at some time so this makes it clearer whatever day it is held.*

Be amended to read :

28.3.1 Chairperson. Governing Council shall annually appoint the Investigations Chairperson.

28.3.1.1 Committee Members. Governing Council shall appoint from time to time, but at least annually, a number of members, that number being as determined by Governing Council from time to time, but the number shall be no less than seven (7). No member shall be a member of the Appeals Board or the Protest and Disputes Tribunal or Judges Board.

*Rationale:*

*The Constitution is currently silent as to the number of members and involvement in other Governance committees. This will bring the Investigations Committee and Protests and Disputes Tribunal into alignment as to their composition and allocation of members*

*This will allow Governing Council to act to ensure there are correct number of committee members available to suit the current conditions. For example, during the Covid situation the pool of available committee members being depleted. Having a greater number of committee members available would have eased this.*

## President Report 2024



### Welcome

Good evening everyone, and thank you for being here. It has been another eventful year for Dogs West and among the matters I would like to highlight this evening are the fiscal management of the Association, the contribution by our Volunteers to the Association, and Member engagement.

### Open Day

The Open Day held this year was well attended and demonstrated once again the affection that people have for dogs. Our ability to provide a great atmosphere to the many Visitors who came along was made possible by the dedicated working party and the many Members who volunteered on the day and had stands. After careful consideration by Governing Council, including costs and the most suitable date, the next Open Day will be held in 2026.

### Financial Matters

Dogs West finished last financial year with an operating deficit of \$143,000, following on from a deficit of \$164,000 in the previous budget year.

Interest income from our investment accounts was largely responsible for the reduction in the overall deficit to \$30,000.

Setting a budget for the 2024/2025 operating year was a challenging process for the Finance Committee and Governing Council. Rising costs and falling income sees the Association with another projected deficit this fiscal year, despite the fee increases that were approved. Governing Council did not make the decision lightly regarding fees, and we recognise that this is not sustainable in the long term.

The sponsorship partnership brokered by our Chief Executive Officer with PD Insurance is a good example of income diversity and, in this first year, is enabling the development of a new website which will offer more online services to our Members and Affiliates, providing improved customer service and public engagement, at no cost to the Association. This work is already underway.

The Association acknowledges our ongoing and valued partnerships with our other major sponsor Royal Canin and with Petstock and also acknowledges other sponsors who support our many Affiliates and Working Parties. Your support is appreciated.

Dogs West has outstanding grounds and facilities. These require weekly maintenance as well as scheduled maintenance to our major assets to ensure their integrity and extending their useful life versus the major cost of replacement. These costs can be significant, and it is vital that the Association maintains a solid investment sum to allow this to occur.

I understand and acknowledge the challenges that Members face with the current cost of living pressures. Our many Club Affiliates

are facing the same scenario of rising costs and falling income, together with falling participation rates in some disciplines. Falling participation, in turn, has a flow on effect to the Association in terms of revenue.

An analysis of registration statistics from Dogs Australia, shows a steady decline in breed registration numbers over time, with a steep decline post the pandemic breeding boom. This is a complex issue Australia wide affected by Government Legislation, the economic climate, the boom of designer dogs and change in ways of living and housing density. Conversely, all surveys show that Australia remains a nation of dog lovers with high ownership rates.

However, the drop in registration numbers has a financial impact on all State Member Bodies with resulting lower revenue, and Dogs West is no exception. Adding to the complexity of this issue for Members is the number of ANKC registered puppies currently advertised for sale, with very high numbers of litters in some breeds looking for homes.

Clearly Dogs West operating with financial deficits cannot continue at this level and a review of all aspects of operations is a priority for Governing Council and the CEO over the next 12 months.

The challenge is to minimise our costs, and to increase our income in the challenging environment we are all facing whilst at the same time maintaining the high standard of amenities and service that Dogs West provide to its members.

### Member Community

In almost every report I have presented to an AGM, and in the President reports published in the Canine News, I have spoken about the Association being a Member Organisation.

Members are the lifeblood of the Association.

Lower participation rates in conformation events particularly, are not unique to our Association, and are being reflected across the country and overseas. Conversely, participation rates in newer disciplines such as Scentwork and Lure Coursing, remain strong and growing.

In a Member community, disharmony and intolerance does not foster a pleasant environment.

The Department of Home Affairs has an Australian Value Statement which states, in part, that Australian society “values the dignity of the individual .....and embraces mutual respect, tolerance, fair play and compassion for those in need”

We all need to carefully consider our interactions with each other and with visitors to our grounds and events. It costs nothing to be pleasant but brings great reward in creating a welcoming place to be.

Social media has a big part to play here. It can be inclusive, informative and entertaining.

Social media posts, at times, do not enhance or promote a positive feeling of Member fellowship. Half-truths, anonymous posts, incorrect advice and posts seeking negative reactions, are not a positive influence.

We all have a responsibility to promote Dogs West and pure bred dogs in the best possible light and I encourage all Members who want our

Association to thrive and to continue doing what we do with our beloved dogs, in your discipline of choice, to consider how your actions or comments might be viewed adversely by other Members and potential members. Kindness and tolerance are all talents we should practice.

On a more positive note, my sincere thanks go to any Member who volunteered in any capacity during the year. We must all recognise that without volunteers many events would simply not happen; all volunteers deserve our acknowledgement, appreciation and respect.

My personal thanks go to all the Members of Governing Council, Dogs West Committees and Working Parties for their untiring efforts over the last year. I am often in awe of your commitment and achievements.

### Land and Asset Matters

The Association has received a draft proposed development plan for the corner lot on Ranford and Warton Roads for our comment. The development encompasses a mix of showrooms, shops, food outlets and a petrol station, much akin to the development styles seen in the wider district. The Developer, at this stage, does not envisage any works commencing in the next 2 years.

A condition report on the roofing of the Administration Building and undercover area has been received and quotes are being sought for the necessary maintenance works required. This cost will be significant and will be covered from our investment reserve.

### Government Legislation

The State Government has announced the outcome of the tender for the Central Registry for dogs and cats (PetsWA) to be developed as an outcome of the passing of the Dog Amendment (Stop Puppy Farming) Act in December 2021.

The Department of Local Government, Sport and Cultural Industries has stated that the new regulations to enact the Legislation are planned to come into effect on the same day that the PetsWA system commences operating. PetsWA is expected to launch later in 2025.

My recent enquiry to the Department on the status of the development of the Regulations and any feedback on our submission, was that it was noted and that we would be contacted in due course re the outcome. The Regulations will drive our further engagement with State and Local Government.

In closing I wish to thank the CEO, Marzel and all her Team, for a year of outstanding support for our Members and the Association. Governing Council has extended their thanks and best wishes to our Financial Controller Ian who is leaving in early September after 9 years with the Association. I am sure all the Members join me in wishing him well.

Thank you again to all the Members for being here this evening.

## CEO Report 2024



### Strategic and Operational Outcomes

I would like to acknowledge the President's Report and highlight the Association's focus over the past two years on attracting different income streams and reducing costs.

The success of the approaches guided by the Finance Committee is

visible by reduction in the operating deficit from 2021/2022 to 2023/2024. Despite the successes to date, the goal is still to have our operations at cost-neutral or small profit.

Amongst the challenges in income, is the continual downward trend of puppy registrations and transfers and the slight decrease in overall membership numbers. The main difficulty relating to expenditure continues to be the high increases in services and utilities costs.

The auditors this year recommended seeking alternative revenues such as merchandise at promotional events and to continue to use fundraising events to keep all Dogs West events at cost-neutral at a minimum. The report also continues to encourage the Association to implement cashless services where possible.

### Strategic and Operational Plans for 2024/2025

These recommendations align with the management plans that have either commenced or are to commence in 2024/2025 and 2025/2026 financial years. Of note, the new website will be launched in the coming months with more online service capability including bookings and schedule submissions.

Once the new website and new streamlined office processes have been implemented, office resources will be reviewed for the 2025/2026 Budget. There will also be some savings due to the reduced numbers of printing and postage of the Canine News Journals this year, with further savings in the 2025/2026 as Membership Cards will have a digital wallet option.

Sponsorship diversity will be a key focus this coming year as the Association seeks partners that can provide direct value to its members and the Association. This includes the commencement of negotiations for the renewal of the pet retail and food contracts as well as seeking new partners from other pet categories.

I would like to thank the Dogs West staff for their efforts and commitment and look forward to working with the team, Governing Council and its Committees to deliver the improved outcomes.

### Member Community

Regarding our member community, I support the President's comments, I thank the very many tireless volunteers that are involved in our Committees, Working Parties and sanctioned events. Everyone's lives seem to be getting busier and I am so grateful for every volunteer that helps this Association deliver services to its members.

I also must note the President's tireless support. Many do not see the work our President puts into the items and discussions presented not just at Governing Council but also representing WA and the national agenda at Dogs Australia director meetings. Her insights and contributions have provided Dogs West with the vision and stability this Association needs. Thank you, Pam, for your years of service. I feel privileged to have had the opportunity to work alongside such an exceptional leader.

I wanted to wrap up on a couple of comments from the President's report regarding some disharmony in parts of the membership. While I believe this is only a small group, I agree social media is allowing rumours the space to breathe and grow. Dogs West's approach moving forward will be to use the communication channels available with the new website to increase the information available to members, improving the FAQs and news sections, addressing questions we see out in our community in a positive and constructive manner. We hope the abundance of information will mean members can refer to a better source of truth than social media commentary.

The President asks our members to consider the impact their actions and comments have on our membership and Association and it reminded me of The Wolf You Feed quote which goes like this:

One evening an old Cherokee told his grandson about a battle that goes on inside people.

He said, "My son, the battle is between two "wolves" inside us all. One is Evil. It is anger, envy, jealousy, sorrow, regret, greed, arrogance, self-pity, guilt, resentment, inferiority, lies, false pride, superiority, and ego.

The other is good. It is joy, peace, love, hope, serenity, humility, kindness, benevolence, empathy, generosity, truth, compassion and faith."

The grandson thought about it for a minute and then asked his grandfather: "Which wolf wins?"

The old Cherokee simply replied, "The one you feed."

What wolf you feed is up to you, but I think it is worth considering before acting. I hope we can stand more united in the years to come.

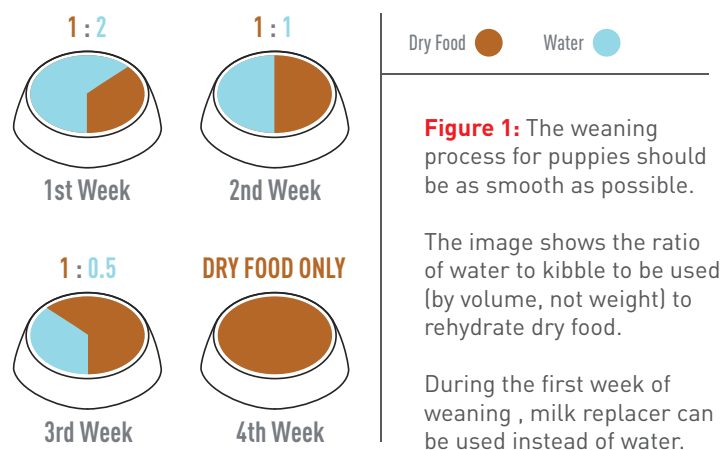

# STARTING OFF ON THE RIGHT DIET FROM WEANING

At 3 to 4 weeks of age, puppy's nutritional needs begin to exceed what can be provided by milk alone, and the nutritional weaning phase should begin. The transition to solid foods should occur gradually. Transitioning from milk to solid food with commercial diets designed for weaning puppies is advised to make this transition even more gradual.

Dry Starter diets are rehydratable with water to make a gruel (1:2 dry food to water) or porridge consistency. Soft mousse Starter diets also bridge the texture gap between milk and dry kibble. Cow's milk should not be used because it contains high lactose concentrations and can cause diarrhea. Milk replacer can be used for the first days of transition, but it has a higher energy density, which can lead to excess weight gain; water is therefore preferred for kibble rehydration.

During the first week of weaning, milk will remain the major food source. Milk production will gradually decline as the puppy begins to eat solid food and are progressively separated from their mother. The deciduous teeth erupt around 21 to 35 days after birth. Thus, by 5 weeks of age, solid foods should be readily consumed and by 6 to 8 weeks of age, weaning is complete. Daily requirements should be divided into four meals minimum to avoid overload & diarrhea.



The nutrient-dense diet that was fed during gestation and lactation should continue as the main diet for at least 3 weeks post-weaning to ensure adequate nutrient replenishment of the bitch. Animals in poor body condition at breeding and whelping may require longer replenishment periods.

All puppies are affected by the immunity gap, a critical period in the transition between the immunity passively transferred from the mother and the development of their own immunity following vaccination. Maternally derived antibodies (MDA) are antibodies against pathogens which bitches have been exposed to or vaccinated against, which are transferred to their offspring in the colostrum, in the first 2 days after whelping.

These antibodies can protect puppies in the initial weeks of life, but they also interfere with vaccination since high MDA levels can prevent the onset of an active immune response. MDA levels decrease over time in the first few months. The immunity gap can last several weeks, usually between 4 & 12 weeks of age, but the period when it occurs is not predictable, and puppies may be susceptible to infection with pathogens during the decline phase of MDA. This is a particular period in their early life, known as immunity gap or window of susceptibility, during which their MDA is still able to interfere with vaccination but not enough to prevent active infection.

Nutrition plays a key role in the healthy development of growing puppies after weaning. The goal is to adequately support the increased nutritional demands of growth while taking care to avoid any excess that could lead to obesity or developmental disease.

Both nutrient deficiencies and excesses can have long-lasting negative effects. Increased levels of essential nutrients during growth such as protein, amino acids, fat, fatty acids, vitamins, and minerals are required to support organs and tissue development.

# Christmas Decorations: Hidden Dangers for Our Dogs

The holiday season is a magical time, but it can also bring risks to our furry companions. With all the lights, decorations, and new scents filling our homes, it's easy for dogs to become curious or overwhelmed. A Christmas tree adorned with sparkling ornaments might be as exciting for your dog as it is for you—but it could also pose hidden dangers.

## Tips to Dog-Proof Your Christmas Tree:

- 1. Tinsel, Ornaments, and Fairy Lights** – These may look like fun toys to your dog, but they can lead to serious health problems if swallowed, such as obstructions or punctures in the digestive system. To keep your dog safe, consider the following:
  - o Set up your Christmas tree a few days before decorating to let your dog adjust to its presence.
  - o Use a sturdy stand or tether the tree to the wall or ceiling to prevent it from being knocked over.
  - o Consider placing a pet gate or tree guard around the base to restrict access.
  - o Keep the lower branches undecorated. Place lights, tinsel, and baubles higher up, out of your dog's reach. These decorations are typically made from materials like plastic, paper, or foil, which are low in toxicity but can still cause choking or blockages if swallowed.
  - o Tape down electrical cords to prevent them from being chewed. Keep Christmas lights and their cables out of your dog's reach, as biting into them can result in electrical shock or ingestion of sharp, broken bulbs.
- 2. Avoid Edible Decorations** – Chocolate coins, candy canes, and even homemade salt-dough ornaments may look festive, but they are hazardous for dogs. Chocolate is toxic, and the high salt content in salt-dough can make your dog seriously ill, causing vomiting, excessive thirst, lethargy, and in severe cases, kidney damage or seizures.

- 3. Wait to Place Presents** – Only put presents under the tree on Christmas Eve to prevent your dog from “opening” them early. This will help minimise the temptation.

## Other Christmas Hazards for Dogs:

- **Poinsettia** – While poinsettias have a reputation for being highly toxic, the effects are usually mild. Their sap can cause drooling, vomiting, or diarrhea if ingested. To be safe, keep this festive plant out of your dog's reach.
- **Snow Globes** – Surprisingly, some snow globes contain ethylene glycol, a chemical that can cause fatal poisoning if ingested. Since ingredient labels aren't typically provided with snow globes, it's impossible to know which ones may contain this chemical. If your dog ingests any liquid from a broken snow globe, seek veterinary attention immediately.
- **Batteries** – Batteries, particularly small button batteries, can cause chemical burns or heavy metal poisoning if chewed and punctured. If swallowed, they can cause a blockage that may require surgical removal. In some cases, button batteries lodged in the throat or gut can produce an electric current, damaging surrounding tissues.
- **Silica Gel Sachets** – These small packets, often found in packaging, are labelled “Do not eat” not because they're toxic but because they're not meant for consumption. However, if your dog swallows a silica gel sachet, it can still cause an intestinal blockage, requiring surgery.

## What to Do in an Emergency

If you suspect your dog has eaten, touched, or inhaled something harmful, contact your vet immediately. Dogs West is not a veterinary organisation, so we advise seeking professional help from your local vet if you're concerned about any of the issues raised in this article.

## HM1 ACKNOWLEDGMENT

Each person, when signing an application for membership or renewal of membership of the Canine Association of Western Australia agrees to the following:

- to be bound by the ANKC Ltd regulations and rules
  - to be bound by the Constitution, Rules and Regulations of the Association
  - to be bound by the Association's Code of Ethics
  - To allow the inspection of the member's premises as required for the purpose of investigating compliance with the regulations and the code of ethics. **04/17**
- 1.2 Each member by signing any document shall be certifying that the information contained therein is true and correct.
- 1.3 A Member shall not forge, falsify or misrepresent the signature of another Member or person on any document relating to the activities of Dogs West or the Australian National Kennel Council Ltd. **(05/21)**

## HM2 CODE OF CONDUCT

- 2.1 A member shall not knowingly or recklessly misrepresent the ANKC or the member's Member Body.
- 2.2 A member shall not engage in any behaviour that is contrary to the standards accepted by the community.
- Members and others defined in HM2.3 will not engage in bullying or harassing or unacceptable behaviours towards other members, staff, volunteers or contractors or disorderly conduct.

- Bullying is defined as repeated inappropriate behaviour direct or indirect, whether verbal, gesture, physical or otherwise, conducted by one person or persons against another person or persons.

This includes, but is not limited to:

- Cyber bullying – placing an offensive or hurtful public message, image or statement on a social network site or other public forum where that message, image or statement can be viewed and/or repeated by other people will be regarded as bullying behaviour.
- Unacceptable behaviour is defined as any behaviour that a reasonable person, having regard for the circumstances, would see as victimising, humiliating, undermining or threatening.
- Disorderly conduct is defined as disturbing the peace or endangering the morals, health or safety of others. **(07/15)**

- 2.3 Members shall be responsible for any and all actions by themselves, their family members or guests when attending sanctioned events and their interactions with other members at all times.

This includes but is not limited to:

- Littering
- Damage
- Unacceptable behaviour
- Bullying

- 2.4 A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- 2.5 A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.
- 2.6 A member shall at all times and in all forums, including at DogsWest approved events, in dealings in wider forums including chat lists on the internet and in all other communications, conduct themselves in a manner respectful of the reputation of the ANKC and DogsWest members, judges, staff and officials. **08/11**
- 2.7 An exhibitor is not to contact a judge after the announcement of that judge's appointment by any means that may be interpreted as promoting that exhibitor or exhibitor's exhibits. This includes social networking sites, email, and all electronic forms of communication as well as traditional forms of communication. Should a judge receive such an approach, they are required to make a report to the appropriate member body and disciplinary action may be taken against the exhibitor. **08/11**

- 2.8 Members shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
- 2.9 Members shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised and receive veterinary care as and when required. A member shall not knowingly allow any dogs under their care to roam at large.
- 2.10 A member shall permit any person authorised in writing by the Administrative Officer, following a resolution of the Governing Council, to enter and inspect any premises owned or occupied by the member for the purpose of investigating compliance with HM2.9 of this Code. 2.10.1  
During the conduct of the inspection the member will permit the authorised person to record any necessary details by tape, video or photographs.  
2.10.2 Failure to permit the inspection of the premises without reasonable cause shall result in suspension of the member's privileges until that inspection has taken place. **(04/17)w**
- 2.11 The registered owner of a dog shall remain ultimately responsible for said dog, including if left in the care of another person.
- 2.12 A member shall take all appropriate lawful measures to assist a dog in distress.
- 2.13 A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community.  
When the dog is away from home a member shall ensure that it is kept on a leash and/or effective control at all times.
- 2.14 A member shall not participate in nor support any activity that involves cruelty or damage to animals, excluding legal hunting activities.
- 2.15 A member shall not dispose of dogs owned or bred by the member to a pound or animal refuge. Breed Rescue Clubs run by ANKC Ltd members are exempt. **(04/20)**
- 2.16 A member shall display good sportsmanship and conduct at all times so as to reflect credit upon themselves, the ANKC Ltd and the member's Member Body. **(08/22)**
- 2.17 A member shall at all times comply with all relevant consumer laws and regulations, both State and Federal. **(08/22) (03/23)**

## BREEDING

- 2.18 A member shall breed primarily for the purpose of improving the quality and / or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market. A member retains the right of free trade, to advertise directly and sell dogs not kept for line maintenance purposes by that member.
- 2.19 A member shall not breed with a bitch unless the bitch has reached adequate maturity for that breed as determined by the member's Member Body. The minimum breeding age for bitches across all breeds is twelve (12) months at the time of mating. Except in extenuating circumstances or with the approval of Governing Council prior to the mating, a member shall not breed from any bitch causing it to be mated before it is twelve months of age. **(08/14)**
- 2.20 A member shall not breed a bitch causing it to whelp **more than twice in any eighteen month period (11/22)**
- 2.21 Number of Litters
- 2.21.1 A member shall not breed a bitch causing it to whelp more than five (5) times.
- 2.21.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch. **(2/23)**
- 2.22 Maximum Breeding Age
- 2.22.1 A member shall not mate a bitch over the age of seven (7) years.  
Note: after the bitch's seventh birthday. **(07/18)**
- 2.22.2 Extenuating Circumstances
- 2.22.2.1 A member may apply to Dogs West for permission to mate a bitch over seven years of age. The application is to include:
- a veterinary certification of fitness for further breeding issued in the last **30** days



- the positive identification of the bitch – microchip
  - reasons for the need for a litter from a bitch of this age
- 2.22.2.2 The member must have obtained written permission PRIOR to mating the bitch
- 2.22.2.3 The permission is valid for a period of six months – after this permission must be re-applied for.
- 2.22.2.4 Under no circumstances will permission for a further litter be granted. **(04/17) (11/22)**
- 2.23 First generation (father/daughter, mother/son, brother/sister) matings are not permitted. ANKC Ltd Member Bodies will not register the progeny of father/daughter, mother/son, brother/sister matings on the Main Register unless application was made to the Member Body and approval was given prior to the mating on the basis of health or genetic reasons to the benefit of the breed. Any breach of this regulation will constitute an offence by the member(s) who are the owners of the sire and the dam of the litter. The progeny resulting from such a breach will be registered on the Limited Register and endorsed 'never to be upgraded' and any further penalties as may be determined by the member's Member Body. Refer ANKC Part 6 – 8.4 **(10/10) (12/14)**
- 2.24 A member shall not permit any of that members' ANKC Pure Bred Registered dogs, without prior approval from the Association, to be used in any mating which would result in a litter being ineligible for registration on the ANKC Register. This includes
- 2.24.1 To a dog of a different breed
  - 2.24.2 To a cross bred dog
  - 2.24.3 to a non ANKC registered dog of the same breed or
  - 2.24.4 to a dog not on the ANKC Main Register
  - 2.24.5 a mating not in compliance with R2.1. **(04/21)**
- 2.25 Breaches of Regulations 2.18, 2.19, 2.20, 2.21 and 2.22 are considered to be a serious breach of the Code of Ethics. For that reason, offences in relation to each of the separate regulations will be considered cumulatively in applying penalties to the Registered Breeder/Member. Any puppies not registered on the Main Register are to be registered on the Limited Register with the endorsement 'Not to be upgraded to Main register'. **(08/11) (04/13)**
- 2.26 A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Code of Practice for Hereditary Diseases.
- 2.27 A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body. Puppies are to be microchipped and vaccinated prior to leaving the Member's care.
- 2.28 A member shall not export a puppy under the age of eleven [11] weeks, or such greater age permitted under the livestock import requirements of the country to which the puppy is being exported.
- 2.29 A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- 2.30 A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.
- 2.31 A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- 2.32 A member **must** register all puppies bred by that member that are living at the date of registration. Such registration must include all living puppies from the litter on the one litter registration application form and must be applied for within six [6] months of the date of whelping.
- 2.33 A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:
- 2.33.1 The breed characteristics;
  - 2.33.2 Current Vaccination certificate signed by a Veterinary Surgeon evidencing that the dog has been immunised against Canine Distemper, Hepatitis and Parvo Virus
  - 2.33.3 Microchip number verification – transfer is the responsibility of the vendor in accordance with R19.
  - 2.33.4 Responsible dog ownership information; and
  - 2.33.5 All documentation required by the member's Member Body, including-
    - 2.33.5.1 a written receipt clearly stating whether, in accordance with R11.1, the dog is to be transferred to the purchaser or a Non-Transfer Agreement executed. **(05/22)**
    - 2.33.5.2 any other conditions of sale and/or agreements **(04/17)**
- 2.34 A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- 2.35 A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.
- 2.36 A member shall not:
- 2.36.1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. Nor shall a member's dog/s be advertised, displayed or sold on commission by a commercial dog wholesaler or retail pet dealer. **(07/15)**
  - 2.36.2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.
- ## GENERAL
- 2.37 A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display must ensure that:
- 2.37.1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
  - 2.37.2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- 2.38 A member shall oppose all activities which involve cruelty to dogs or in which dogs inflict damage on other dogs or other animals excluding the hunting of vermin.
- 2.39 A breeder must include their ANKC Ltd Member Body Membership Number in any advertisement for puppies whatever the media and all members must include the following wording in their advertisements:  
"Please contact Dogs West on email: [k9@dogswest.com](mailto:k9@dogswest.com) to verify my membership."
- 2.40 A member shall not use or cause to be displayed, in any form or in any media, their Dogs West membership number in relation to any progeny, real or planned, from a dog not on the ANKC MAIN register. **(06/20)**
- 2.41 A member shall not declare, make or infer any relationship, in any form or in any media, between their membership of The Association, The Association and any dog not eligible for entry onto an ANKC register. **(06/20)**
